ORCID webinar on indigenous data sovereignty

In October 2020, ORCID, along with the Global Indigenous Data Alliance (GIDA), hosted an online webinar on indigenous data sovereignty. This webinar described what is meant by the term indigenous data sovereignty, covered the FAIR principles for data (Findable, Accessible, Interoperable, and Reusable) and the CARE principles for indigenous data governance (Collective Benefit, Authority to control, Responsibility, and Ethics). A new initiative in the form of digital 'labels' (localcontexts.org) was described, along with early ideas on how these could potentially be introduced into ORCID records. ORCID and two factor authentication

Your users may not be aware of ORCID's two-factor authentication facility

Two factor authentication (2FA) offers an additional level of security when signing into a service. In addition to signing into ORCID using your ORCID ID or email address and password you can set up the ability to receive a one-use code that you also enter, as part of the login process. A 2FA app is required to create the code. ORCID have tested several apps including Authy, FreeOTP, Google Authenticator and Microsoft Authenticator.

From an ORCID membership perspective, you can allow people to sign into another system that you control via sign-in from ORCID. ORCID will tell you if they are using 2FA. If you want an extra level of security when users sign into your system you can make it a requirement that your users have 2FA implemented in ORCID to sign into your system via this route

ORCID at the Royal Society Te Apārangi

Since 2019, the Society has enabled Society members, and applicants to the schemes that we administer, to present authenticated ORCID ids. The Society is using these identifiers to simplify identification of people coming into these schemes; especially useful where people have shifted institutions or otherwise changed email addresses. The Society also intends to restart asserting funding success to ORCID records.
