eResearch NZ 2023 in Hamilton report–February 2023

The eResearch NZ conference series has increasingly become a home for discussions on the state of data and data practice in New Zealand. As a consequence, it's a natural home for opening views on the value for New Zealand in having a national PID strategy. It was a pleasure for the Society's ORCID team to be there for the PID Birds of a Feather workshop, and to see so many of our Consortium members there. We believe it's fair to say that ORCID in New Zealand has been a success, but that more work needs to be done. In particular, more and richer integrations are needed to return value to New Zealand's researchers. Of note, a full digital ecosystem approach to the use of PIDs has been recently estimated as having the potential to save researchers and research systems significant sums in time, effort, and thus money: in Australia this is calculated as AU\$24M and 38,000 person-days per year. Details about this study can also be found in our previous newsletter.

ORCID Global Consortia Workshop 2023

The ORCID Global Consortia workshop took place on 24 March 2023 in Gothenburg, Sweden. There were consortia representatives present from 16 countries around the world and the New Zealand Consortium was represented by Alex Freemantle. The workshop was a brilliant opportunity to forge stronger relationships with other consortia and to discuss best practices. The programme of events included workshops discussing Building Consortia, Feedback and Communication between ORCID and Consortia Leads and the opportunity to present successful integration stories. A summary report will be compiled for the next Advisory Committee meeting.

New ORCID consortia pages

ORCID have overhauled the layout, design and content of the consortia pages on their website. It is hoped that this will make the content clearer and easier to understand. ORCID webinars

The <u>I'm a member, now what</u> programme of webinars are designed to help new members get the most out of their memberships and to accelerate both their integration development and the uptake of ORCID within their organizations. The most recent session, on 2 February 2023, focused on <u>Integrating with ORCID</u>, where best practices were shared, as well as a discussion regarding the various types of integrations. The next webinar in the series will be held on 13 April 2023 and will focus on <u>Custom Integrations</u>.

ORCID Community Town Hall 2023

The international ORCID Community Town Hall took place on 28 March 2023. The ORCID senior management team shared details of the progress made in 2022 and provided a preview of the plans

for 2023. These plans include making progress on accessibility compliance, providing researchers with "Record Summaries", and focusing on development within the global south, as well as many other goals. A full recording of the meeting can be found <u>here</u>.

The ORCID registry has grown, now with over 16 million records, which means there is a requirement for a new block of identifiers.
