CONZUL Open Access Toolkit

A new Open Access Toolkit for Aotearoa New Zealand researchers has been created under the direction of the Council of Aotearoa New Zealand University Librarians (CONZUL), a committee of Universities New Zealand. The toolkit is designed to guide researchers through the process of ensuring their research articles are published Open Access. The process is split into five stages of publishing: planning the research, selecting a journal, submitting the manuscript, on acceptance and after publication. One of the key steps discussed in the Open Access Toolkit is signing up to ORCID and adding the published article to your ORCID record. ORCID Search and Link Wizards can be used to support the researcher in doing this.

Weltec & Whitireia Research Seminar Series

A Royal Society Te Apārangi representative recently delivered a presentation at the Weltec & Whitireia Research Seminar Series. The session included a presentation to attendees which focused on the benefits of ORCID membership for researchers and examples of the ORCID work that can be undertaken in the ITP sector. ORCID Global 2023 Annual Report

The <u>ORCID Global 2023 Annual Report</u> has been released. This year was the second full year of ORCID's current strategic plan, <u>From Vision to Value</u>: <u>ORCID's 2022–2025 Strategic Plan</u>, and

progress has been made towards the four priorities that were defined in 2021. These priorities are: Increasing Value to Members, Increasing Value to Researchers, Increasing Global Participation, Upholding Trust and Integrity. In addition, in 2023 Improving Staff Experience was added as a fifth theme.

Registry Updates prompt Affiliation addition

A new release from ORCID now makes it easier for researchers to populate their ORCID record right from the beginning! Now when a new user registers, they will be prompted to add an employment affiliation either manually, or from a suggestion based on the email domain being entered. This will ensure that more users' records include an accurate affiliation.

ORCID webinars

ORCID have launched the <u>ORCID On-Demand</u> service which allows users to catch up on webinars anytime. This is particularly useful for any webinars that fall outside of our time zone. The recent ORCID webinar series such as the Enabling Value series and the I'm a Member, Now What series are hosted on the ORCID On-Demand site.
